Cacciatore	Joseph	1,000	Attorney and Rezko business partner who owned a big stake in the Roosevelt/Clark project.

Davis	Allison	13,550	Attorney turned developer who built low-income apartments and homes with Rezko. With Rezko's recommendation, Blagojevich appointed Davis to Illinois State Board of Investment. Obama once worked at Davis' law firm when Rezko was a client.
